DIRECTOR GENERAL'S OVERVIEW OF PROGRESS SINCE THE TWENTY-SECOND SPREP MEETING IN 2011

INTRODUCTION

This report updates SPREP Members and Partners on developments at SPREP since the 2011 SPREP Meeting and outlines steps being taken to make SPREP a more effective organisation to better meet the needs of Pacific Island Countries and Territories (PICTs). Annex A, outlines disbursements made to SPREP Member Countries in 2011, and details of specific activities undertaken in SPREP Member Countries in 2011. Please look through this list and take this as a measure of our commitment to better respond to your identified needs and priorities and support their implementation.

SPREP achievements over the last year are also detailed in the 2011 Annual Report which will be tabled at the 2012 SPREP Meeting and also in the Performance Monitoring and Evaluation Report (PMER) which will be discussed at the 2012 SPREP Meeting.

It has been my pleasure to have visited 20 SPREP Member countries since starting at SPREP nearly 3 years ago — thank you very much to all involved for your warm hospitality. I have placed a high priority on these visits to SPREP members and, in particular, to meeting with key persons in all member countries to see at first hand your environmental challenges and to discuss with you how SPREP can best assist your efforts and improve our level of service delivery.

MAKING SPREP A MORE EFFECTIVE REGIONAL ORGANISATION

The last year has been a period of major change for SPREP

SPREP Members at their annual meetings have provided clear instructions to develop SPREP into a more effective and focused regional organisation. In response, SPREP has undertaken a comprehensive and ambitious change management process, to make SPREP better able to respond to, and support, our Pacific island members.

This has been guided by four key principles:

- 1) to improve and increase the delivery of tangible and relevant services to SPREP Members;
- 2) to improve SPREP's governance, particularly internal processes for managing staff and money;
- 3) to strengthen SPREP's partnerships, including with other regional organisations; and
- 4) to improve the link between SPREP's policy work with science and practical, on ground demonstration projects.

It is noted that principles (2),(3), and (4) are all directed at supporting principle (1) - to improve and increase the delivery of tangible and relevant services to SPREP Members. I am pleased SPREP's ambitious change management process is showing many positive results and some of these are briefly outlined below.

(1) SPREP has improved and increased the delivery of tangible and relevant services to its Members.

SPREP has improved and increased the delivery of tangible and relevant services to its Members. Highlights included:

- Increasing SPREP support to Member Countries and Territories during the past year, as can be clearly seen through the list of all projects SPREP implemented in Member Countries in 2011 (Annex A) and the most recent SPREP Annual Report (2011), available at www.sprep.org and tabled at the 2012 SPREP Meeting;
- (2) Doubling SPREP's direct financial and technical support for member countries over the 2009-2011 period, with SPREP's direct financial support to Pacific island countries and territories increasing from US\$2.4 million in 2010 to US\$4.3 million in 2011, while support for SPREP Member regional level activities increased from US\$7 million in 2010 to US\$8.3 million in 2011;
- (3) Overall the total SPREP budget increased from US\$7.6 million in 2009 to US\$14.3 million in 2012. It is anticipated that the 2013 budget will shown another significant increase and this will be reported at the 2012 SPREP Meeting. Over this period, salary costs as a percentage of the total SPREP budget have dropped from 49% in 2009 to 33% in 2012. The growth of SPREP's budget has not been about increasing the number of staff at SPREP. In fact there has only been a modest growth in staff numbers from 2008 to 2012. The major increase in the funding for SPREP has been mostly allocated to practical programmes in Pacific Island countries and territories. We believe this growth in the SPREP budget reflects a growing confidence and trust of donors in the SPREP programme and in our performance, including our improved financial management. We value this trust and will work hard to maintain it;
- (4) SPREP have responded clearly and effectively to the directions from members, at a general level, through increasing our level of support to Member activities, and, in particular, through implementing the majority of decisions from last years' SPREP meeting, as outlined in Working Paper 4 for this meeting.

SPREP's 2011 Annual Report highlights the breadth of work SPREP is undertaking to support Pacific countries to better manage and protect their environments and address key challenges such as climate change. Over the last year there has been excellent progress in helping Pacific countries better manage their solid waste, address marine pollution, better protect and manage important species and ecosystems, and respond to the overarching impacts of climate change. Highlights over the last year include:

Climate Change

Climate change remains a major challenge facing our region. SPREP recognizes climate change as a reality with enormous impact on the way of life and livelihoods of Pacific peoples. The impacts of climate change cut across all sectors and require integrated approaches, involving all relevant agencies. During 2011 the flagship Pacific Adaptation to Climate Change (PACC) Project, a joint GEF funded initiative between SPREP and UNDP, has shifted emphasis from planning to the delivery of practical on ground projects in SPREP Member countries, in sectors such as water, agriculture and coastal infrastructure. PACC welcomed a number of other key donors and partners in 2011, including the Governments of Australia (AusAID) and the United States (USAID). A key feature of the PACC

approach is identification of country priorities and bringing together key sectors to work together to address climate change.

SPREP provided substantial support for Pacific country preparations for the Durban Climate Conference in 2011. This very important UN meeting showcased island countries speaking with one voice, along with key partners such as the European Union. Our message was heard "loud and clear" in Durban — that the small island countries of the Pacific and other island regions are the most vulnerable on Earth to the impacts of climate change and that urgent assistance is required and that it is required now. Pacific countries welcomed the initiation of the Green Climate Fund and called for it to become operational as soon as possible.

In addition to PACC, SPREP undertook a number of other practical programmes during the year to help Pacific island countries address climate change. Work continued on SPREP's renewable energy project, PIGGAREP, which supported countries to achieve their ambitious renewable energy targets. PIGGAREP, is supporting application of different renewable energy sources in the Pacific and has a focus on removing barriers to adoption of renewable energy in Pacific countries and territories.

A major programme of support for Meteorological Services in the Pacific was also developed over the last year, with support from the Government of Finland. This will focus on building capacity of national Met services in pacific countries. SPREP has also undertaken many capacity building and awareness activities, such as the training of Pacific communication and media experts to better communicate climate change issues to the peoples of the Pacific.

Biodiversity and Ecosystem Management

<u>During the past year SPREP has</u> strengthened its work on biodiversity, particularly through starting new projects on invasive species, on island biodiversity, and on marine conservation through the landmark Oceanscapes initiative, led by a number of Pacific Island countries.

Marine species were in the spotlight in 2011 as we celebrated the Pacific Year of the Dugong, and implemented many programmes to raise awareness about protecting dugongs in the Pacific. As well as being culturally significant to Pacific peoples, dugongs have a vital ecological role in maintaining coastal sea-grass habitats. In our region, dugongs are rated as vulnerable to extinction, with the Palau dugong population particularly at risk because of its geographic isolation.

The Year of the Dugong highlighted that biodiversity is the cornerstone of life in the Pacific - our plants, animals, and ecosystems are essential for livelihoods and have shaped Pacific culture and traditions. Our precious Pacific biodiversity is at risk as never before. We continue to lose biodiversity at an unprecedented rate, with extinctions rates for some species being the highest in the world. SPREP expanded efforts to protect and better manage biodiversity in Pacific countries with, as noted above, two new major projects starting, both funded through GEF-PAS and matching contributions: one on island biodiversity, focused on protection of species, and another focused on invasive species.

The Pacific Ocean covers 34% of the Earth's surface, with only 2% comprising land. Identification and protection of marine biodiversity is thus critically important. During the year SPREP supported the Pacific Oceanscapes proposal - an important initiative called for by Pacific leaders to better manage and protect our lifeblood – the Pacific Ocean.

Waste management and pollution control

SPREP Meetings from 2008 to 2010 directed the Secretariat to increase attention to waste management and pollution – we now have significantly increased resources at SPREP to this area and have joined forces with the Governments of Japan and France, and others, to help Pacific Island countries and territories better address this important issue. SPREP also has a number of major proposals in the pipeline which, if successful, will also provide a major boost to waste management and pollution in our region.

Pollution control and waste management are major development issues for Pacific island countries as waste and pollution pose major threats to the sustainable development of the Pacific region with their significant impacts on our environments, health, water and quality of life. There are many dimensions to the problems of waste and pollution, and SPREP has also expanded into the areas of hazardous waste management with particular attention to ensuring better management of chemicals, asbestos, and waste oil in our region.

Environmental Monitoring and Governance

SPREP's 2011-2015 Strategic Plan places strong emphasis on environmental monitoring and governance. During the year we provided support to many Pacific countries in these areas including through support for the development of laws and policies, environmental impact assessment and the strengthening of capacity. The innovative EU-funded project Capacity Building related to Multilateral Environmental Agreements (MEA) in African, Caribbean and Pacific (ACP) Countries was a key vehicle for supporting Pacific countries to build their capacity in implementing multilateral environmental agreements such as those dealing with climate change and biodiversity.

(2) SPREP has improved its governance and particularly its internal processes for managing staff and money

We have substantially improved financial and human resources systems at SPREP, with an emphasis on improving performance, efficiency and service delivery to members. Over the past year we have invested considerable time in overhauling and improving our financial and human resource systems and processes to tighten our accountability. We have placed emphasis on ensuring our management is open and consultative. We regularly meet as a full Secretariat and our Executive Team is reporting regularly to staff in an open and transparent manner.

As one indication of our improvement, we are delighted that SPREP passed the European Union (EU) "5 Pillar Institutional Assessment" in 2011 after not meeting EU assessment requirements in 2009.

SPREP has improved its governance with a major restructuring process which has bought the structure of SPREP in line with the 2011 - 2015 Strategic Plan, which was prepared following the largest consultative exercise in SPREP's history, including surveys of SPREP Members and Partners, and a number of sub regional consultative workshops. The new structure of SPREP was approved by the 2011 SPREP Meeting and I am pleased to report this structure is now fully operational.

Over the last year SPREP has undertaken a number of measures to reduce operating costs, including through: (a) increasing use of video conferencing, which reduced travel and per diem costs for SPREP over the last year; (b) reduction of SPREP per diem rates from 100 to 80% of the UN rates. This saved SPREP over US\$200,000 over the last year which was re-directed to practical on ground activities in Pacific countries and territories; and (c) iimprovement to SPREP internal systems. The SPREP Director General has also tried to lead by example and has forgone his right (under his contract) to Business

Class travel with the resultant savings applied to capacity development of the SPREP Secretariat and Members. All savings achieved have been applied to improving services to SPREP Members throughout the Pacific.

SPREP also focussed on building its own capacity in 2011. Our aim is to attract and retain the highest quality of staff so we can better serve our member countries. We are pleased that the retention of staff has increased with the percentage of staff staying at SPREP, as a percentage of total staff, increasing from 76% in 2008 to 93% in 2011. During this time we are also pleased to have seen a major increase in staff morale at SPREP, as assessed through the annual staff satisfaction survey.

I am pleased to report that SPREP has allocated modest funds to support capacity building of SPREP staff, for the first time in the history of SPREP. This reflects our priority on recruiting and retaining the best calibre of staff to SPREP to enure we can better serve our SPREP Member countries and territories.

SPREP has improved its internal systems. For example, we developed and implemented a new state of the art Human Resource Management System, which includes a shift to performance based pay and which is strongly grounded in a new Statement of Organisational Values Code of Conduct developed by SPREP staff. We are also implemented other actions to make SPREP a more effective and accountable organisation, including through the development of a functioning and effective Senior Management Team and development of policies and other improvements to SPREP finance and human resource systems.

These improvements are enabling SPREP to better deliver practical and tangible services to SPREP Member countries and territories in the Pacific.

(3) SPREP has strengthened its partnerships, including with other regional organisations to better support delivery to Members

The challenges facing the Pacific are vast and require better cooperation between SPREP and its partners and donors. We recognize the critical role of partnerships to SPREP's work. In 2011, relations were strengthened through signing MoUs with a number of key partners, including the Secretariat of the Pacific Community and other regional agencies. New and innovative partnerships were initiated with Westpac on the Clean Pacific Campaign, due to start in 2012, and with the 5Cs – the Caribbean Community Climate Change Centre and also with the Indian Ocean Commission at the Rio+20 Summit in June 2012. The latter partnership will share expertise and experience between Pacific, Caribbean and Indian Ocean countries on climate change and other matters.

These partnerships will greatly increase support for Pacific countries to better manage their environment and address key challenges such as climate change. For example, Japan has recently committed \$US12 million to supporting country efforts to better manage their solid waste and is implementing this project through SPREP. The Australian International Climate Change Adaptation Initiative has partnered with SPREP to support practical efforts by countries to adapt to climate change. SPREP is hosting staff from Japan and Australia at our offices in Apia

We are pleased that a number of key countries and partners have increased their support to SPREP during the year. SPREP values this trust and commits to working hard to make sure we earn it. Better partnerships such as these are improving SPREP's efforts to support Pacific country efforts on environmental management and sustainable development.

(4) SPREP has improved the link between its policy work with science and practical, on ground demonstration projects.

SPREP has taken a number of measures to better ground its work on science and good information. Our aim is not to develop SPREP as a pure research organisation but rather to ensure that our practical in country programmes and our policy advice is better grounded on state of the art science. To this end we have developed partnerships with universities and research institutions such as the University of Maryland to strengthen the scientific basis of our work in Pacific island countries and territories. We will continue and expand this over the years ahead.

CONCLUSION

SPREP is becoming a more efficient and effective organization that can better serve the needs of Pacific countries and territories. SPREP is working closely with Members and partners to ensure that together we can rise to and meet the many challenges faced by the Pacific relating to climate change, biodiversity and ecosystem management, waste management and pollution, and environmental monitoring and governance. Improvements undertaken over the last year enable SPREP to better deliver practical and tangible services to SPREP Member countries and territories in the Pacific.
