6.1 Strengthening Regional Linkages	59	<p>The Meeting:</p> <ul style="list-style-type: none"> ➤ noted the developments in relation to the placement of technical officers in FSM and RMI, and the respective host agreements to be finalised with the two Member governments; ➤ directed the Secretariat to continue strengthening its partnership mechanisms with the MSG to enhance coordination and delivery of services; and ➤ directed the Secretariat to review the effectiveness of the Desk Officers arrangement, including a cost benefit analysis for consideration by the 2014 SPREP Meeting. 	<ul style="list-style-type: none"> ➤ A technical officer (Moriana Phillip) was appointed in RMI in February 2014. The FSM appointment is currently in process and should be finalised shortly; ➤ The host country agreement with RMI was finalised in July 2014; ➤ SPREP signed an MoU with MSG in December 2013 and positive and effective co-operation has commenced; ➤ Due to the recent appointments of technical officers in 2014 the Secretariat has requested that the review of the effectiveness of the arrangement, including a cost benefit analysis, be deferred to the 2015 SPREP Meeting. ➤ Please refer to Agenda item 6.1 for further information on action on this matter
6.2 Accessing Multilateral Financing - Global Environment Facility (GEF) and Adaptation Fund (AF) Accreditation	70	<p>The Meeting:</p> <ul style="list-style-type: none"> ➤ noted the progress made on the Adaptation Fund and GEF Accreditations and encouraged the work to be continued as soon as possible; ➤ encouraged Members of SPREP, who are also Members of the GEF and the AF, to strongly support the accreditation application of SPREP to these agencies to become a GEF Project Agency and noting that in regards to GEF this requires a second 	<ul style="list-style-type: none"> ➤ SPREP has been accredited as a Regional Implementing Entity, under the UNFCCC Adaptation Board. This means that SPREP is now one of only three RIES's in the world, with the other two located in Africa. This is a significant achievement which will benefit SPREP members and is a strong indication and validation of the strength of the governance processes and procedures at SPREP. ➤ The MSP project document has undergone UNDP's local project

GEF informed UNDP and SPREP in July that this project will now not be part of GEF 5 but will part of the GEF 6 Cycle. We are waiting on further advice from GEF on the GEF 6 project submission process. SPREP will continue to work with UNDP to finalise documents for submission to GEF for the CEO endorsement as soon as possible. SPREP will receive USD 900,000 to implement capacity building activities while UNDP receives approximately USD 100,000 as its GEF Project Agency fee. 9.2.3 Climate Change Roundtable (PCCR) and Regional Disaster Risk Management (DRM) Platform Joint 2013 (Roadmap)	250	<p>The Meeting:</p> <ul style="list-style-type: none"> ➤ noted the outcomes of the Joint Meeting; ➤ endorsed SPREP's role in progressing the joint meeting outcomes; ➤ invited SPREP Members and Partners to discuss and support SPREP's role in the roadmap process; ➤ invited members of SPREP to take into account this decision in the SPREP budgeting process for the coming years; ➤ requested the Secretariat to seek funding for the Roadmap process and report back to the 2014 SPREP meeting; and ➤ noted Australia's reservation on recommendations 3, 4 and 5. 	<ul style="list-style-type: none"> ➤ SPREP has been leading and/or supporting the work of each of the PCCR five Working Groups and have utilized these in developing papers, seeking information and disseminating new documents; ➤ The roadmap process has progressed well and SPREP has been actively engaged in its development. 9.4.4 Facilitating Resilient Development in the Pacific: Strengthening Capacity in the Use of Cost-Benefit Analysis (P-CBA Initiative)	325	<p>The Meeting:</p> <ul style="list-style-type: none"> ➤ endorsed the proposed P-CBA Initiative; and ➤ requested that Pacific Members submit an Expression of Interest (EOI) letter to the P-CBA Working Group through their national SPREP focal points, who together with the Ministries of Finance will be the lead co-ordinating agency for this initiative. 	<ul style="list-style-type: none"> ➤ The P-CBA Initiative is being implemented collaboratively by SPREP, SPC, PIFS, USP, UNDP GIZ, USAID and ADB - building on the materials developed and lessons learned from the PACC CBA Work Program. ➤ 7 PICs are participating in the P-CBA Initiative and are being supported through existing regional projects such as the PPCR.
