### Agenda Item 7.1 : Report on Members' Contributions

#### Purpose of Paper

1. To report to the Meeting on the receipt of Members' contributions.

#### Background

2. Financial Regulation 14 requires the Director to submit to each SPREP Meeting a report on the receipt of Members' contributions. This report provides an update on the status of Members' contributions received in 2014 (up to 31st July) as well as sharing the status of members' contributions as at the end of 2013. A verbal update on any Member contributions received after 31 July will be provided to the 2014 SPREP Meeting.

#### Members' Contributions received in 2013 and 2014 (to 31 July 2013)

3. Attached for Members' information is a statement which shows the amounts due from respective Members as at 31 July 2014. As the table indicate, a total of USD\$1,213,338 was received by the Secretariat in 2013 leaving a balance USD\$389,393 of unpaid contributions as at 31 December 2013.
4. The total unpaid contributions as at 31 July 2014 is USD\$717,839 made up of USD\$388,551 unpaid for the 2013 year and prior years, and USD\$329,288 for 2014.
5. Contributions due for 2014 are \$1,069,774 and as of 31st July, the Secretariat has received US\$741,324 in respect of the 2014 contributions, and prior years unpaid contributions.
6. The Secretariat has made a considerable effort in 2013/2014 to encourage Members to pay their contributions, including through numerous reminder letters sent from the Director General to Member Focal Points, and also through follow up with senior officials when the DG visits member countries and territories.
7. It is noted that previous SPREP Meetings have discussed and agreed a re-payment schedule for Nauru regarding outstanding membership contributions.

8. Other than Members with small adjusting balances, the following are Member countries with outstanding contributions as at 31 July 2014 for both 2014 and prior years contributions:
