Thirteenth Meeting of the Conference of the Parties to the Convention to Ban the Importation into Forum Island Countries of Hazardous and Radioactive Wastes and to Control the Transboundary Movement and the Management of Hazardous Wastes within the South Pacific Region (Waigani Convention)

Agenda Item 2: Organisation of the Meeting

Purpose of paper:

1. To explain the Rules of Procedure for the conduct of the Meeting and to elect officials.

Background:

- 2. The Rules of Procedure of the Waigani Convention apply to the meeting in accordance with Article 13 of the convention. Copies may be obtained from https://archive.iwlearn.net/sprep.org/legal/documents/approvedRulesofProcedforWaigani.pdf.
- 3. Rule 18 of the Rules of Procedure provides that at the commencement of the first session of each Ordinary meeting; a Chairperson, Vice Chairperson and Rapporteur are to be elected amongst the representatives of the Contracting Parties by a simple majority vote.
- 4. At the twelfth meeting, the Conference of the Parties elected Solomon Islands as the Chairperson, Kiribati as Vice Chairperson and Australia as Rapporteur.
- 5. There are 13 Parties to the Waigani Convention: Australia, Cook Islands, Federated States of Micronesia, Fiji, Kiribati, New Zealand, Niue, Papua New Guinea, Samoa, Solomon Islands, Tonga, Tuvalu and Vanuatu.
