

## Updated Information Note of CBCRP-PCCC Training Programs in 2022

### BACKGROUND

- The Project for Capacity Building on Climate Resilience in the Pacific (CBCRP-PCCC) by SPREP, the Government of Samoa and Japan International Cooperation Agency (JICA) aims to support operationalization of the training function of the Pacific Climate Change Centre (PCCC).
- This information note provides an updated schedule of the training programs to be delivered in 2022 under the CBCRP-PCCC, and support their nomination processes and active participation. The major change is that the training program on health previously planned in November and December 2021 is now rescheduled to March-April 2022.
- The planned training programs in 2022 will focus on adaptation and mitigation in the prioritized sectors of Tourism, Health and Water as well as Understanding Access to Climate Finance.

### SCHEDULE

The CBCRP-PCCC plans to deliver the following 5 training programs in 2022.

Month	Sectors / Themes
24 January – 18 February	Tourism
March – April	Health
July – August	Water
September – October	Understanding Access to Climate Finance, Part 3&4 (Project planning and management)

The official invitation of each training program will be sent from SPREP to the climate change focal points of the Pacific Island Countries and Territories and Timor-Leste NAO, and the focal points are expected to nominate participants from the relevant sectors. The number of participants per country/territories will be confirmed in the official invitation.

### OBJECTIVES

The overall goal of the CBCRP-PCCC training programs is to enhance capacities on climate resilience in the Pacific. The training programs under the CBCRP-PCCC aim to:

- Strengthen participants' capability to contribute to the national adaptation planning and the implementation of National Adaptation Plan (NAP);
- Enhance understanding of vulnerability of targeted sectors to climate change, and expertise of adaptation and mitigation options of targeted sectors using real-life country examples;

- Develop skills to execute problem trees analysis and logical frameworks development to contribute concept note development for targeted sectors; and
- Enhance understanding and gaining basic skills in planning budgeting and proposal writing for project formulation and implementation, project management and oversight functions.

Specific objectives of each training program will be informed in an official invitation.

## **TARGET PARTICIPANTS**

It is expected that government and non-government officials and practitioners including the private sector, who are working in the units of relevant sectors and climate change, will join these training programs. We encourage gender diversity and we kindly request that the nomination is gender balanced, where possible.

Please note the project team have informed the climate change focal points that the same participants of the training programs of Understanding Access to Climate Finance Part 1 & 2 in November and December 2020 are expected to join the remaining Part 3 & Part 4 of this subject (please see [SPREP Circular 20/90 on 28<sup>th</sup> October 2020](#)).

## **DELIVERY FORMAT**

Due to COVID-19 pandemic, the training programs in 2022 are planned to be delivered on the PCCC E-Learning Platform. However, delivery formats will be revised based on changes of travel restrictions.
