**SUBJECT: Invitation to the Pacific Climate Change Roundtable (Donor and Development Partners Climate Finance Dialogue), 13 – 15 August 2025, Apia, Samoa**

Dear Partners,

It is my pleasure to inform you that the Pacific Climate Change Roundtable (PCCR) 2025 will take place at the Taumeasina Island Resort in Apia, Samoa, from Wednesday 13<sup>th</sup> – Friday 15<sup>th</sup> of August 2025.

The role of the PCCR is to provide SPREP's national climate change focal points with a platform to advance their national climate change priorities, strengthen networks and ensure enhanced regional collaboration towards Pacific climate change priorities and improved access to the effective financing necessary to deliver them.

In alignment with the decisions from the 2024 roundtable, the PCCR will:

- Facilitate engagement and dialogue to draw on the challenges, lessons learned, and successes gained in the implementation of national policies and strategies;
- Strengthen regional climate change collaboration by working together to determine and advance Pacific priority thematic areas;
- Promote the exchange of knowledge on ongoing, emerging and innovative solutions, research, technologies and opportunities from the national context to address climate change issues in the region; and
- Provide a platform for countries, donors and partners to collaborate, to deliver more effective climate finance access for Pacific Island Countries and Territories (PICTs).

The agenda and concept note for the PCCR will be circulated to those registered for the event following the closure of the deadline for nominations. Further, for the awareness of our partners, the PCCR will be held subsequent to the First PSIDS Youth Loss and Damage Dialogue and the Second PSIDS Regional Loss and Damage Dialogue (7 – 12 August 2025).
