Country Technical Assistance Opportunity

What is the Country Technical Assistance for?

The PacWastePlus (PWP) Programme is currently engaged with focal points as we confirm country projects with the intent many should be completed and submitted in June 2020. As the team is working with 15 countries, we recognise that countries may need additional support, so the programme team have undertaken an assessment of consultants that can be asked to assist.

We have developed a register of pre-approved technical consultants, through an advertised Tender process, and also have produced [individual consultant profiles](#) that provides more detailed background information to support countries on the development of project concepts for in-country interventions on any one or more of the programme priority waste streams or project activity areas.

These technical experts will be available for PacWastePlus programme participating countries focal points to call upon for assistance in the development of country project proposals.

How does it work?

To assist countries develop their in-country projects, each country is able to seek up to **10 hours of specialist consultant support** (*these 10 hours may be sourced from a single, or multiple consultants, where required*) from the list of pre-approved consultants provided in this information sheet.

This opportunity is designed to enable country Focal Points to answer specific technical questions that they may not have the resources available, or cannot access the PWP Programme Management Unit due to capacity.

The service is only available to assist with the completion of the PacWastePlus programme in-country project development. Once completed, we would need written confirmation of the hours being completed for the relevant consultant engaged.

Please note that all services provided by the consultant will be undertaken remotely to countries.

Steps for accessing Technical Assistance



Determine the issue/topic

Consider the project plan you are working on, and determine the issue/topic you feel you need technical support to complete.



Select relevant consultant(s)

Review portfolio of pre-approved consultants and choose the one (*or more*) you would like to get assistance from.



Inform us of support required

Provide details to PMU of the question you need answered/support required and your preferred Consultant.



Engagement of consultant

PacWastePlus will engage the consultant(s) and put them in touch with you.



Contract payment

Confirm to us when task is completed and PWP will complete contract and pay the consultant for the approved hours.
