Question 1:

Can SPREP confirm whether any historical soil or groundwater sampling data exist for the Pohnpei Used Oil Dump or the Kosrae Power Plant sites? If so, can it be shared with us?

Response:

SPREP is unaware of any historical soil or groundwater sampling data that exists for the Pohnpei Used Oil Dump or the Kosrae Power Plant sites.

Question 2:

Does SPREP require a minimum number of soil and/or groundwater samples per site for Phase II investigations, or should sampling density be determined by the Consultant based on Phase I findings?

Response:

SPREP does not require a minimum number of soil and/or groundwater samples per site for Phase II investigations.

Question 3:

For the Kosrae Power Plant Site B (Transformers), should the Phase II analytical suite include PCBs in addition to petroleum hydrocarbons?
