1. Background

- 1.1. The Secretariat of the Pacific Regional Environment Programme (SPREP) is an intergovernmental organisation charged with promoting cooperation among Pacific islands countries and territories to protect and improve their environment and ensure sustainable development.

2. Specifications: statement of requirement

- 2.1. SPREP wishes to call for tenders from qualified and experienced consultants who can offer their services to be engaged as Protected Areas and Biodiversity Adviser (Service-Based Consultancy) for the EU-ACP Pacific BioScapes Programme, to work on a service consultancy basis and provide specific technical and advisory support to the project.
- 2.2. The Terms of Reference of the consultancy are set out in Annex A.
- 2.3. The successful consultant must supply the services to the extent applicable, in compliance with SPREP's Values and Code of Conduct: <u>https://library.sprep.org/sites/default/files/sprep-organisa-tional-values-code-of-conduct.pdf.</u> Including SPREP's policy on Child Protection, Environmental Social Safeguards, Fraud Prevention & Whistleblower Protection and Gender and Social Inclusion.
- 2.4. SPREP Standard Contract Terms and Conditions are non-negotiable

3. Conditions: information for applicants

- 3.1. To be considered for this tender, interested consultants must meet the following conditions:
 - i. Submit a detailed Curriculum vitae detailing qualification and previous relevant experience for each proposed personnel;

- ii. Provide three referees relevant to this tender submission, including the most recent work completed;
- Complete the tender application form provided (Please note you are required to complete in full all areas requested in the Form, particularly the Statements to demonstrate you meet the selection criteria DO NOT refer us to your CV. Failure to do this will mean your application will not be considered).
 Provide examples of past related work outputs For the Technical and Financial proposals you may attach these separately.
- iv. Must meet local registration requirements
- 3.2 Tenderers must declare any areas that may constitute conflict of interest related to this tender and sign the **conflict of interest form** provided.
- 3.3 **Tenderer is deemed ineligible due to association with exclusion criteria, including** bankruptcy, insolvency or winding up procedures, breach of obligations relating to the payment of taxes or social security contributions, fraudulent or negligent practice, violation of intellectual property rights, under a judgment by the court, grave professional misconduct including misrepresentation, corruption, participation in a criminal organisation, money laundering or terrorist financing, child labour and other trafficking in human beings, deficiency in capability in complying main obligations, creating a shell company, and being a shell company.
- 3.4 Tenderer must sign a declaration of **honour form** together with their application, certifying that they do not fall **into** any of the exclusion situations cited in 3.3 above and where applicable, that they have taken adequate measures to remedy the situation.

4. Submission guidelines

- 4.1. Tender documentation should demonstrate that the interested consultant satisfies the conditions stated above and in the Terms of Reference and is capable of meeting the specifications and timeframes. Documentation must also include supporting examples to address the evaluation criteria.
- 4.2. Tender documentation should be submitted in English and outline the interested consultant's complete proposal:
 - a) SPREP Tender Application form and conflict of interest form. (Please note you are required to complete in full all areas requested in the Form, particularly the Statements to demonstrate you meet the selection criteria DO NOT refer us to your CV. - e) Financial Proposal provide a detailed outline of the costs involved in successfully delivering this project submitted in United States Dollars (USD) and inclusive of all associated taxes.
- f) Where relevant provide:
 - i. Business registration/license (For Entities/ Individual consultant's as per relevant national legislations)
 - ii. Tax Identification Number (TIN) Letter (If applicable for Individual consultant's as per relevant national legislations)

- 4.3. Provide three referees relevant to this tender submission, including the most recent work completed.
- 4.4. Tenderers/bidders shall bear all costs associated with preparing and submitting a proposal, including cost relating to contract award; SPREP will, in no case, be responsible or liable for those costs, regardless of the conduct or outcome of the bidding process.
- 4.5. The tenderer/bidder might be requested to provide additional information relating to their submitted proposal, if the Tender Evaluation Committee requests further information for the purposes of tender evaluation. SPREP may shortlist one or more Tenderers and seek further information from them.
- 4.6. The submitted tender proposal must be for the entirety of the Terms of Reference and not divided into portions which a potential tenderer/bidder can provide services for.
- 4.7 The Proposal must remain valid for 90 days from date of submission.
- 4.8 Tenderers must insist on an acknowledgement of receipt of tender.

5. Tender Clarification

- 5.1. a. Any clarification questions from applicants must be submitted by email to procurement@sprep.org before 09 May 2024. A summary of all questions received complete with an associated response posted on the SPREP website www.sprep.org/tender by 14 May 2024.
 - b. The only point of contact for all matters relating to the RFT and the RFT process is the SPREP Procurement Officer.
 - c. SPREP will determine what, if any, response should be given to a Tenderer question. SPREP will circulate Tenderer questions and SPREP's response to those questions to all other Tenderers using the SPREP Tenders page (<u>https://www.sprep.org/tenders</u>) without disclosing the source of the questions or revealing any confidential information of a Tenderer.
 - d. Tenderers should identify in their question what, if any, information in the question the Tenderer considers is confidential.
 - e. If a Tenderer believes they have found a discrepancy, error, ambiguity, inconsistency or omission in this RFT or any other information given or made available by SPREP, the Tenderer should promptly notify the Procurement Officer setting out the error in sufficient detail so that SPREP may take the corrective action, if any, it considers appropriate.

6. Evaluation criteria

- 6.1. SPREP will select a preferred consultant on the basis of SPREP's evaluation of the extent to which the documentation demonstrates that the tenderer offers the best value for money, and that the tender satisfies the following criteria:
- 6.2. A proposal will be rejected if it fails to achieve 70% or more in the technical criteria and its accompanying financial proposal shall not be evaluated.

If SPREP determines that none of the Tenders submitted represents value for money, that it is otherwise in the public interest or SPREP's interest to do so, SPREP may terminate this RFT process at any time. In such cases SPREP will cancel the tender, issue a cancellation notice and inform unsuccessful bidders accordingly.

Annex A: Terms of Reference

Protected Areas and Biodiversity Adviser (Service-Based Consultancy), Federated States of Micronesia (FSM), EU-ACP Pacific BioScapes Programme.

Background

Funding has been received under the EU-ACP *Pacific Biodiversity and Sustainable Land-Seascapes* (*Pacific BioScapes*) *Programme*. The programme, a 5-year initiative managed and implemented by the Secretariat of the Pacific Regional Environment Programme (SPREP), will contribute to the sustainable development of Pacific SIDS by supporting and improving the management and sustainable use of marine and coastal resources. It provides an opportunity to address critical issues concerning coastal and marine biodiversity, and ecosystem-based responses to climate change adaptation. Pacific SIDS continue to face growing environmental challenges with the potential to drastically impact the natural assets upon which the foundation of their national economies and community livelihoods depends. The programme will apply ridge-to-reef and other management approaches to take into account both marine and terrestrial environments and to contribute to addressing barriers to effective conservation and sustainable use of biodiversity.

The islands of the FSM are home to some of the most biologically diverse terrestrial and marine areas in the world. FSM's unique plants and animals exist in the context of a full range of ecosystems and communities found across the islands in the FSM, and thus, these ecosystems themselves must be protected. As the governors of all living and non-living resources from land to twelve nautical miles seaward from the traditional baseline, state governments bear the principal responsibility for the management, protection, and development of all resources within their respective boundaries. States, therefore, must be encouraged and supported by the national government in their efforts to protect biodiversity in the FSM through the creation of protected areas. This process must also involve non-governmental organizations (NGOs), municipalities, traditional leaders, communities and individual resource owners in order to be successful.

The FSM is signatory to the Convention on Biological Diversity (CBD) and committed, in 2006, to the regional Micronesia Challenge initiative to *effectively conserve at least 30% of the region's near-shore marine resources and 20% of terrestrial resources by 2020*. During the 24th Micronesia Island Forum in 2019, the Leaders recognized the success of the Micronesia Challenge 2020 and endorsed the new Micronesia Challenge 2030 goals to *effectively manage 50% of marine resources, including the exclusive economic zone (EEZ), and 30% of terrestrial resources by 2030*. In line with these commitments, the FSM have developed and endorsed the Protected Areas Network National Guiding Policy Framework, with the aim of establishing a nationwide Protected Areas Network (PAN) to allow the national government to assist states and communities in the protection of significant areas of biodiversity, key habitats, and other valuable resources that are important to the future stability and health of the FSM. The PAN will also assist the national government, states and other partners to leverage and secure technical and funding partnerships from regional and international entities.

Objectives:

- To advise on the National Protected Area Network (PAN) and biodiversity issues to strengthen implementation of the FSM National PAN Policy Framework (2015), and related strategies and plans for biodiversity conservation in the Federated States of Micronesia
- To provide assistance with preparations for relevant regional and international meetings (e.g., Convention on Biological Diversity, Micronesia Challenge etc.)

Scope of Work

Advise the national focal point of the Convention on Biological Diversity (CBD) providing strategic, policy, and technical advice to the FSM Department of Resources and Development (FSM R&D) to support departmental priorities for the conservation and sustainable use of biological diversity, with particular focus on the FSM PAN.

Roles and Responsibilities

The consultant will work remotely from his/her home, under the supervision of the Assistant Secretary for the Marine Resources Division within the FSM R&D. The Consultant will work closely with the FSM's CBD national focal point, with the national PAN Coordinator and with national and state level stakeholders on the following:

- Assess national level needs/requests for support to investigate FSM biodiversity goals, under the PAN Focal point and CBD Focal point supervision.
- Provide strategic, policy and technical advice and assistance on all biodiversity and related matters that support R&D work in ecosystem and biodiversity protection in the country, including but not limited to the Protected Areas Network, the Micronesia Challenge, the Convention on Biological Diversity and the National Biodiversity Strategies and Action Plans (NBSAPs).
- Contribute to areas of work related to biodiversity management, enhancement and protection, such as the update of biodiversity framework and related plans, PAN policy work and various aspects of biodiversity management related to implementation of national (i.e., PAN), regional (i.e., Micronesia Challenge), and international (i.e., Convention of Biological Diversity) commitments.
- Provide strategic, technical and policy advice on key emerging biodiversity and related issues and their potential implications on the work of R&D on ecosystem and biodiversity protection, with particular focus on the implication to the FSM Protected Areas Network (PAN).
- Provide relevant advice to the FSM's PAN Focal point and CBD Focal point on biodiversity related issues and implications to the FSM PAN, including possible solutions to address these issues and technical matters to inform key institutional decisions, national legislation (policies or regulations) and project management guidance, including technical advice on biodiversity and related projects.
- As needed, provide guidance and advice on key capacity building and training needs for biodiversity and PAN, including opportunities in biodiversity and related thematic areas.
- Identify the most optimal system for Knowledge Management to enable access to information for, and transfer of, knowledge within the country and regional and international governments and institutions;
- Contribute to planning, preparing, and participate to the CBD technical and COP meetings (virtually
 or in person), and assist in aligning contents to other relevant Multilateral Environmental Agreements (e.g. UNFCCC, Samoa Pathway, Agenda 2030 Global Goals) and National policies and
 regulations, including PAN.
- Conduct a mapping exercise of finance and other sustainable development finance initiatives in the region, focusing on biodiversity and Protected Areas, and highlight entry points for cooperation, in cooperation with relevant Regional Hubs and Institutions.
- Explore and promote linkages with climate finance opportunities (e.g. Nature-based Solutions), seeking synergies at the country level and ensuring coherence with other interventions such as PAN.

- Interim Consultancy Report.
- Final Consultancy Report.

Remuneration

Financial offers should be made in USD based on a monthly rate; the budget for services provided is up to **USD 90,000.**

Payments will be made upon submission of monthly reports and its acceptance by the Pacific BioScapes Project Manager and Marine Resources Division in FSM, this is to be accompanied with appropriate invoices, in accordance with an agreed workplan.

Work arrangements

The consultant will work remotely from his/her home, under the supervision of the Assistant Secretary for the Marine Resources Division within the FSM R&D. She/He will work closely and maintain regular communication with the FSM's CBD, PAN focal points and with SPREP.

The Consultant will be given access to relevant information necessary for execution of the tasks under this assignment, and she/he will be responsible for providing her/his own laptop and other equipment needed.

Travel arrangements

The consultant is expected to travel to and participate in one technical meeting and travel to and fully participate in one CBD COP. Agreed and approved travel will be arranged in line with SPREP's travel policy.

Communication

It is expected that all communications related to delivering on the tasks outlined in these terms of reference will be conducted through online/virtual means, if not differently stated.

Duration

The consultancy is expected to run for one year (12 months).

- Strong technical skills with demonstrated ability to provide strategic policy advice across various environmental themes related to the Convention on Biological Diversity, interlinkages between biodiversity and climate change, relevant regional and national policies, plans and strategies related to biodiversity.
